

WELCOME DEALERS

We have some changes in our contract listed below. Please take notice.

- We received some feedback from patrons in past shows about early break down by dealers. Patrons were paying to enter the show, and came to dealers already breaking down or in the process, causing a number of patrons to complain and many admissions refunded. Please be aware that **your** buyers come in throughout the day to view the show and purchase merchandise. WE ASK ALL VENDORS TO STAY SETUP UNTIL 2:30PM AND BREAK DOWN NO EARLIER.
- CONFIRMATION OF YOUR CONTRACT IS ONLY RETURNED WITH AN ENCLOSED S.A.S.E. YOUR CHECK IS YOUR RECEIPT.
- PLEASE NOTE THAT BOXES TO THE LEFT ON THE CONTRACT NEED TO BE INITIALED BY DEALER.
- NO MATTER HOW MANY TABLE SPACES ARE RENTED, ONE HELPER PER DEALER. ADDITIONAL HELPERS ARE \$25.00 EACH (SAME PRICE).
- ALL WALL SPACES NOW INCLUDE TABLE. \$100.00 PER SPACE.
- ALL END CAP TABLE SPACES NOW INCLUDE 8FT TABLE. \$100.00 PER SPACE.
- OUR DEALER DEMAND FOR TABLES WAS UP 50% LAST DECEMBER, AND WE EXPECT THIS DEMAND TO CONTINUE.

DEALER CONTRACT

GREATER BOSTON ANTIQUE TOY SHOW & SALE – SUNDAY, APRIL 2, 2017

ALL EXHIBITORS MUST INITIAL BOXES TO LEFT AND AGREE TO THE FOLLOWING:

- We charge an entry fee to our shows and people expect to see collectible toys not readily available in stores. Please exhibit collectible toys!
- This Contract is for use of a 6' table or floor space 6' long. **IT IS UNDERSTOOD THAT PARTICIPATION IN THIS SHOW IS BY INVITATION ONLY, and conditional.** Blue Dog Promotions, Inc., at its sole discretion, can refuse to invite or admit any exhibitor or patron. **SOLICITING OF DEALERS OR FOR OTHER SHOWS IS NOT ALLOWED.** However, show literature may be placed on the Literature table at the Entrance.
- SET UP TIME FOR EXHIBITORS IS 7:00 AM. 2 WRIST BANDS, ONE FOR YOU AND ONE FOR YOUR HELPER, WILL BE WAITING FOR YOU AT THE ENTRANCE. ONE HELPER PER EXHIBITOR. EXTRA HELPERS: \$25 EACH. THESE WRIST BANDS ARE YOUR EXCLUSIVE PASS TO THE SHOW AND CANNOT BE TRANSFERRED.** Remember, a helper is someone who works for you at your table, not just a friend, dealer or visitor at the show.
- EACH SPACE MUST BE **MANNED AND OPERATING FROM 9:00AM TO 3:00PM.** IF YOU CANNOT REMAIN SET UP AND AVAILABLE UNTIL 3:00 PM, DO **NOT SIGN UP FOR THIS SHOW!**
- ASSIGNMENT OF SPACE** is by Show Management only. We cannot guarantee 'same spot' or any specific location. In order to reserve any space, you must **PAY IN ADVANCE.** No telephone reservations or payments on the day of the show. All payments paid with this contract are non-refundable. Should we be sold-out when we receive your application, you will be notified and your money returned. **If you've signed up for this show and find you can't make it, call us.**
- AISLES MUST BE KEPT CLEAR** for safe access throughout show hours. Exhibitors shall **NOT BLOCK FIRE EXITS** or set up beyond allotted space, encroach on aisles or other exhibits, or entrance to exhibits. **TABLES MAY NOT BE REPOSITIONED. ALL MERCHANDISE MUST BE DISPLAYED ON OR DIRECTLY UNDER YOUR TABLE.** Decision of Show Management will be accepted in all disputes.
- WEATHER:** RE: STORMS, SO LONG AS THE HOLIDAY INN IS OPEN TO SERVE THE PUBLIC, THE SHOW IS ON! In the event that the Holiday Inn closes, table rent is non-refundable.
- OTHER CANCELLATION:** If the Show is canceled by Blue Dog Promotions for any reason before or on the day of the Show, Blue Dog Promotion's sole responsibility to Exhibitor is to return space payment made by Exhibitor, and neither party shall have any further rights, obligations, or liabilities to the other. If you are unable to make the show due to inclement weather, your table rent is non-refundable.
- EXHIBITORS SHALL REFRAIN** from sound or music in their displays or exhibits, and shall NOT display material that would be offensive to children or adults. Blue Dog Promotions, Inc., reserves the right to demand removal by Exhibitor of any items which Show Management determines are not in keeping with the Show's image. If Exhibitor refuses to comply, then Show Management shall have the right to demand that Exhibitor pack his/her exhibit and depart from the Show.
- EXHIBITORS** must be able to provide consumers with detailed receipts that include vendor's name. The State of Massachusetts requires you to have a copy of your Mass. Sales Tax Certificate with you, retain receipts records, and add the tax to the price of items on receipts (no Tax included assumptions.) Failure to comply with State, Local, and Federal requirements may be reasonable cause for cancellation of contract. **EXHIBITORS** will comply with house rules as outlined by the hotel management and will not interfere with the hotel operation. No pets are allowed without prior consent of Show Management.
- BLUE DOG PROMOTIONS** reserves the right to make such additional rules and regulations as it deems proper and necessary, and Exhibitor agrees to accept such rules and regulations and any interpretation of such as set by Show Management.
- CONTRACT:** This Contract is not valid or effective until signed by a principal of Blue Dog Promotions. **This Contract cannot be assigned (given or sold to someone else.)** This Agreement and performance hereunder, and all suits and proceedings herein shall be interpreted and construed pursuant to the laws of Massachusetts.
- INDEMNIFICATION:** Blue Dog Promotions, its agents, officers, or employees shall not be liable for property damage or personal injury to Exhibitor, its agents or employees, which may occur on or about any part of the hotel premises, regardless of how such injury or damage may have occurred. Exhibitor waives any claim against Show Management and assumes all liability for loss or damage to Exhibitor's property entrusted to the premises. Exhibitor shall hold Show Management harmless and shall indemnify Show Management against all liability or expenses arising out of any claim of injury **for their own insurance for bodily injury, property damage, & products (theft or loss of merchandise!)**
- ARBITRATION:** Any controversy or claim arising out of or relating to this Agreement or breach thereof shall be settled by arbitration in Massachusetts, in accordance with the rules of the American Arbitration Association. Judgment on the Decision rendered shall be final and may be entered in any Court having jurisdiction. The party adjudicated by the Court to be in wrongful breach shall bear the reasonable attorney's fees and costs of the prevailing party. (This is a legal document and we suggest that it be reviewed by your attorney.)
